Great to hear from you. And yes, of course, very pleased to set up a call when i get back to Atlanta in the 2nd week of May. Let me know if there are any days/times that work particularly well for you and I'll do my best to accommodate.

Re. publications, i'll have to dig a bit for any gene-drive-specific social engagement references. I'm working on a couple of papers on this at the moment, but they're no where near ready to share. In the meantime, the closest i have is a retrospective case study we did for the Eliminate Dengue folks for their Wolbachia mosquito trials in norther australia, a much older paper that emanated from some work we did in preparation for caged field trials of GM mosquitoes in Mexico, and a separate paper re. some of the site selection considerations we worked through in preparation for selecting the site in Mexico. My thinking has evolved quite dramatically since then, but it will at least show you where we started

Hope that's modestly helpful, at least to get the ball rolling.
